Due to an administrative error, the grant of 336 restricted shares to the reporting person on June 30, 2018 and the grant of 347 restricted shares to the reporting person on September 30, 2018 in exchange for director fees and reported on the Form 4 filed by the reporting person on July 3, 2018 and October 2, 2018 respectively, should have instead been paid in cash.
