Mr. Dobbin is Chairman of the Board of SII. As of December 19, 2012, SII owns 60.93% of the outstanding common stock of Good Times Restaurants Inc. Mr. Dobbin disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest therein. Mr. Dobbin has 5,667 shares of underlying presently exercisable stock options.
