On March 25, 2013, the Bank was accepted as a registered issuer and on July 22, 2013 the Program was registered as a registered program under Part I.1 of the National Housing Act (Canada) (the "NHA") and the Canadian Registered Covered Bond Programs Guide (the "Guide") by Canada Mortgage and Housing Corporation ("CMHC") in accordance with their terms. The exhibits filed herewith are Exhibit 4.1, an amending agreement to the second amended and restated trust deed dated February 3, 2016 (the "Second A&R Trust Deed Amendment"), which amends the second amended and restated trust deed dated December 4, 2014, which superseded and replaced the amended and restated trust deed dated August 15, 2014 (the "Second A&R Trust Deed") and Exhibit 4.2, an amending agreement to the guarantor agreement dated February 3, 2016 ("Guarantor Agreement Amendment"), which amends the guarantor agreement dated July 19, 2013 (the "Guarantor Agreement"). The Second A&R Trust Deed and the Guarantor Agreement were previously filed with the Commission.

The Second A&R Trust Deed has been revised by the Second A&R Trust Deed Amendment and the Guarantor Agreement has been revised by the Guarantor Agreement Amendment to provide for program updates.
