- (1) These restricted stock units convert into common stock on a one-for-one basis.

The number of shares underlying the option cannot be determined at this time, but will be based on \$150,000 divided by the Black-Scholes valuation of the option on the grant date. Once the number is determined, Mr. Samuels will file an amendment to this report.
