based on the closing price per share on February 22, 2016. The withholding of vested shares pursuant to this award was approved by the Board of Supervisory Directors of the Issuer, and the number of shares indicated in this Form 4 was acquired as treasury stock by the Issuer.

- Mr. Latiolais may be deemed to beneficially own the shares of common stock, par value Euro 0.01 per share, of the Issuer (the "Common Stock") held by a child. Mr. Latiolais disclaims beneficial ownership of the Common Stock, except to the extent of his pecuniary interest therein.
- (3) On February 23, 2015, the reporting person was granted 16,361 RSUs, vesting ratably in three annual installments beginning on February 23, 2016.
