- (2) The Reporting Person directly owns 0 shares of the Common Stock. TM and TOA directly own 0 shares of Common Stock. TP directly owns 11,694,195 shares of Common Stock. TOF directly owns 6,544,966 shares of Common Stock. The separately managed accounts directly own 378,795 shares of Common Stock.
