On October 4, 2018, Meta Financial Group, Inc. effected a 3-for-1 forward stock split of issued and outstanding shares of the Company's common stock ("Common Stock"), in the form of a 200% stock dividend (the "Stock Split"). The number of shares and share prices reported have been adjusted to reflect the Stock Split.
 - (3) An increase of 14,277 shares (adjusted from 4,759 shares due to the Stock Split on 10/04/2018) occurred in the personally held shares of Mr. Tull due to the dissolution of the Crestmark Employee Stock Ownership Plan (the "Crestmark ESOP") on 11/01/2018. The shares were transferred from the Crestmark ESOP to an IRA directly held by Mr. Tull.
