Haifa, Israel, July 20, 2009 - Elbit Systems Ltd. (NASDAQ:ESLT) announced today that it signed an agreement for the acquisition of the assets of BVR Systems (1998) Ltd. (OTCBB:BVRSF.OB) for a price of \$34 million, subject to accounting adjustments.

The closing of the transaction is subject to the fulfillment of certain conditions including receipt of all approvals required by law.

BVR Systems (1998) Ltd. is a leader in the area of development and production of training, simulation and debriefing systems for air, sea and ground forces.

Joseph Ackerman, President and CEO of Elbit Systems Ltd. commented: "We welcome BVR's employees to the Elbit Systems family.
