  - (1) Reflects the withholding of shares to satisfy tax payment for vested shares of Restricted Stock Units (RSU) under the Company's 2007 Omnibus Incentive Compensation Plan. Under the terms of the plan, the fair market value of any fractional share of Common Stock not used to satisfy the withholding obligation will be paid in cash at the time the RSU's are settled.
  - (2) Each restricted stock unit represent a contingent right to receive one share of Company common stock.
  - (3) The restricted stock units vest in four equal annual installments beginning on February 14, 2009.
