- (ii) Mr. Maltese directly owned 1000 shares of Common Stock. By reason of his position as Managing Member of SOAM, Mr. Maltese may also be deemed to beneficially own 522,600 shares of Common Stock, constituting, in the aggregate, approximately 5.14% of the shares outstanding.
