**Tata Motors Group global wholesales at 87,566 in July 2013**

**Mumbai, August 14, 2013:** : The Tata Motors Group global wholesales in July 2013, including Jaguar Land Rover, were 87,566 nos. Cumulative wholesales for the fiscal were 335,067 nos.

Global wholesales of all commercial vehicles -Tata, Tata Daewoo and the Tata Hispano Carrocera range -- were 40,882 nos. Cumulative commercial vehicles wholesales for the fiscal were 161,088 nos.

Global wholesales of all passenger vehicles in July 2013 were 46,684 nos. Cumulative passenger vehicles wholesales for the fiscal were 173,979 nos.

Global wholesales of Tata passenger vehicles in July 2013 were 11,522 nos. Cumulative wholesales for the fiscal were 48,197 nos.

Global wholesales for Jaguar Land Rover were 35,162 vehicles. Jaguar wholesales for the month were 7,174 vehicles and cumulative wholesales were 25,751 vehicles, while Land Rover wholesales for the month were 27,988 vehicles and cumulative wholesales were 100,031 vehicles. Cumulative wholesales for Jaguar Land Rover for the fiscal were 125,782 vehicles.
