- (1) The Restricted Stock Units ("RSUs") were granted under the Company's 2016 Stock Incentive Plan ("Plan") in consideration of the Reporting Person's service as a director. Each RSU represents a contingent right to receive one share of Kforce Inc. common stock.
- (2) The transaction is disclosing a dividend that is exempt from reporting under Rule 16a.
- (3) As previously reported, on April 29, 2016 the Reporting Person was granted 5,260 RSUs, which vest one year from the date of grant subject to the Reporting Person's continued service with Kforce Inc. as of the vesting date. The 34 dividend equivalent rights being reported were credited to the reporting person's account on June 10, 2016.
