This Amendment No. 10 amends the Statement on Schedule 13D (the "Schedule 13D") filed with the Securities and Exchange Commission (the "Commission") on May 27, 2003, by Blum Capital Partners, L.P., a California limited partnership ("BLUM L.P."); Richard C. Blum & Associates, Inc., a California corporation ("RCBA Inc."); Blum Strategic GP, L.L.C., a Delaware limited liability company ("BLUM GP"); Blum Strategic Partners, L.P., a Delaware limited partnership ("Blum Strategic"); and Richard C. Blum, the Chairman and a substantial shareholder of RCBA Inc. and a managing member of BLUM GP (collectively, the "Reporting Persons"). This amendment to the Schedule 13D relates to the shares of Common Stock, \$0.01 par value (the "Common Stock") of Haemonetics Corporation, a Massachusetts corporation (the "Issuer"). The principal executive office and mailing address of the Issuer is 400 Wood Road, Braintree, MA 02184. The following amendments to the Schedule 13D are hereby made. Unless otherwise defined herein, all capitalized terms shall have the meanings ascribed to them in the Schedule 13D.

## Item 5. Interest in Securities of the Issuer

-----  
Item 5 of the Schedule 13D is hereby amended as follows:

(a), (b) According to the Issuer's most recent Form 10-Q, there were 24,237,965 shares of Common Stock issued and outstanding as of December 28, 2002. Based on such information, after taking into account the transactions described in Item 5(c) below, the Reporting Persons report beneficial ownership of the following shares of Common Stock: (i) 448,500 shares of Common Stock held by BLUM L.P. and RCBA, Inc. on behalf of the limited partnerships for which BLUM L.P. serves as the general partner, or on behalf of an entity for which BLUM L.P. serves as investment advisor, which represents 1.9% of the outstanding shares of the Common Stock; (ii) 1,228,500 shares of Common Stock held by BLUM GP on behalf of the limited partnership for which it serves as the general partner, which represents 5.1% of the outstanding shares of the Common Stock; and (iii) 751,400 shares of Common Stock that are legally owned by Carpenters Pension Trust for Southern California ("Carpenters") and 42,200 shares of Common Stock that are legally owned by United Brotherhood of Carpenters Pension Plan ("UBC") (collectively, the "Investment Advisory Clients"). The Investment Advisory Clients represent 3.2% of the outstanding shares of the Common Stock. Each Investment Advisory Client has entered into an advisory agreement with BLUM L.P., but neither Investment Advisory Client has any contract, arrangement or understanding with the other Investment Advisory Client, or any other Reporting Person, with respect to the acquisition, ownership, disposition or voting of any shares of the Common Stock. Each Investment Advisory Client disclaims membership in a group with any Reporting Person or with the other Investment Advisory Client, and each disclaims beneficial ownership of any shares beneficially owned by the Reporting Persons other than for their own account. Voting and investment power concerning the above shares are held solely by BLUM L.P. and BLUM GP. The Reporting Persons therefore may be deemed to be members in a group, in which case the group would be deemed to have beneficial ownership of an aggregate of 2,470,600 shares of the Common Stock, which is 10.2% of the outstanding Common Stock. As the sole general partner of BLUM L.P., RCBA Inc. is deemed the beneficial owner of the securities over which BLUM L.P. has voting and investment power. As Chairman, director and a substantial shareholder of RCBA Inc., Richard C. Blum might be deemed to be the beneficial owner of the securities beneficially owned by RCBA Inc. Additionally, Mr. Blum may be deemed to be the beneficial owner of the securities over which BLUM GP has voting and investment power. Although Mr. Blum is joining in this Schedule as a Reporting Person, the filing of this Schedule shall not be construed as an admission that he, or any

owner of any of the securities that are beneficially owned by RCBA Inc. or BLUM GP.

(c) The reduction in holdings includes all shares legally owned by The Common Fund for which BLUM L.P. maintained voting and investment power, and whose shares were therefore deemed to be beneficially owned by BLUM L.P. The Reporting Persons are advised that The Common Fund is considering whether to register its Multi-Strategy fund as a mutual fund, thereby precluding third party management by the Reporting Persons of The Common Fund's equity positions. Since the most recent filing of Schedule 13D, the Reporting Persons sold the following shares of the Common Stock pursuant to Rule 144 and distributed to The Common Fund the shares of the Common Stock shown below:
