(1) On June 6, 2006, the Company issued its previously declared stock dividend of one share of Class A Common Stock on each share of Class A Common Stock and each share of Class B Common Stock issued and outstanding on the record date of May 22, 2006. As a result of the stock dividend, the Phillip D. Yeager 1994 GST Trust received 46,794 shares of Class A Common Stock.

(2) 64,426 of the shares of Class A Common Stock are restricted stock subject to vesting requirements. In addition, Mr. Yeager received 292,403 shares of Class A Common Stock as a result of the stock dividend issued on June 6, 2006.
