This is being filed to reflect additional limitations on vesting applicable to the previously-reported award due to Interim Final Regulations issued by the U.S. Department of Treasury under Section 111 of the EESA as amended by the ARRA. The restricted stock shall not become transferable any earlier than as permitted under the following schedule (except as necessary to reflect a merger or acquisition of

- (1) the Company): (i) 25% of the shares at the time of repayment of 25% of the aggregate financial assistance received by the Company under EESA (the financial assistance); (ii) an additional 25% of the shares (50% total) at the time of repayment of 50% of the aggregate financial assistance; (iii) an additional 25% of the shares (75% total) at the time of repayment of 75% of the financial assistance and (iv) the remainder at the time of repayment of 100% of the financial assistance.
