Istanbul, Turkey: May 29, 2014 - Turkcell (NYSE: TKC, BIST: TCELL) the leading communications and technology company in Turkey, today announced that the Annual General Meeting dated May 29, 2014 could not convene since the 51% meeting quorum required by the articles of association of Turkcell has not been reached.

ABOUT TURKCELL:

Turkcell is the leading communications and technology company in Turkey, with 34.8 million subscribers as of March 31, 2014. Turkcell is a leading regional player with its approximately 70.1 million subscribers in nine countries as of March 31, 2014. It has become one of the first among the global operators to have implemented HSPA+. It has achieved up to 43.2 Mbps speed using the Dual Carrier technology, and is continuously working to provide the latest technology to its customers. Turkcell Superonline, a wholly owned subsidiary of Turkcell, is the first telecom operator to offer households fiber broadband connection at speeds of up to 1,000 Mbps in Turkey. As of December 2013, Turkcell's population coverage is at 99.49% in 2G and 86.17% in 3G. Turkcell reported a TRY2.9 billion (US\$1.3 billion) revenue with total assets of TRY21.5 billion (US\$9.8 billion) as of March 31, 2014.
