**Preliminary Terms**

**Issuer:** Citigroup Global Markets Holdings Inc.

**Guarantee:** All payments due on the securities are fully and unconditionally guaranteed by Citigroup Inc.

**Underlyings:** The S&P 500<sup>®</sup> Index and the Russell 2000<sup>®</sup> Index

**Stated principal amount:** \$1,000 per security

**Pricing date:** December 17, 2018

**Issue date:** December 20, 2018

**Valuation dates:** December 17, 2019, December 17, 2020, December 17, 2021, December 19, 2022 and December 18, 2023 (the “final valuation date”)

**Automatic early redemption:** If, on any valuation date prior to the final valuation date, the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the fifth business day immediately following that valuation date for an amount in cash per security equal to \$1,000 plus the premium applicable to that valuation date. If the securities are automatically redeemed following any valuation date prior to the final valuation date, they will cease to be outstanding and you will not receive the premium applicable to any later valuation date.

**Premium:** The premium applicable to each valuation date will be determined on the pricing date and will be within the ranges indicated below. **The premium may be significantly less than the appreciation of any underlying from the pricing date to the applicable valuation date.**

- December 17, 2019: 8.25% to 9.25% of the stated principal amount
- December 17, 2020: 16.50% to 18.50% of the stated principal amount
- December 17, 2021: 24.75% to 27.75% of the stated principal amount
- December 19, 2022: 33.00% to 37.00% of the stated principal amount
- December 18, 2023: 41.25% to 46.25% of the stated principal amount

**Maturity date:** Unless earlier redeemed, December 21, 2023

**Underlying return:** For each underlying on any valuation date, (i) its closing value on that valuation date *minus* its initial underlying value *divided by* (ii) its initial underlying value

**Trigger value:** For each underlying, 60% of its initial underlying value

If the securities are not automatically redeemed prior to maturity, you will receive at maturity, for each security you then hold, an amount in cash equal to:

§ If the final underlying value of the worst performing underlying on the final valuation date is **greater than or equal to** its initial underlying value:

\$1,000 + the premium applicable to the final valuation date

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its initial underlying value but **greater than or equal to** its trigger value: \$1,000

**Payment at  
Maturity:**

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its trigger value:

\$1,000 + (\$1,000 × the underlying return of the worst performing underlying on the final valuation date)

**If the securities are not automatically redeemed prior to maturity and the final underlying value of the worst performing underlying on the final valuation date is less than its trigger value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity.**

December 17, 2020	$\$1,000 + \text{applicable premium} = \$1,000 + \$165.00 = \$1,165.00$
December 17, 2021	$\$1,000 + \text{applicable premium} = \$1,000 + \$247.50 = \$1,247.50$
December 19, 2022	$\$1,000 + \text{applicable premium} = \$1,000 + \$330.00 = \$1,330.00$
December 18, 2023	$\$1,000 + \text{applicable premium} = \$1,000 + \$412.50 = \$1,412.50$

There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.
