Item 1.01 Entry into a Material Definitive Agreement.

On June 15, 2009, Proliance International, Inc. (the Company) entered into the Thirty-Fifth Amendment (the Thirty-Fifth Amendment) of the Credit and Guaranty Agreement (as amended prior to June 15, 2009, the Agreement) by and among the Company and certain domestic subsidiaries of the Company, as guarantors, the lenders party thereto from time to time (collectively, the Lenders), Silver Point Finance, LLC (Silver Point), as administrative agent for the Lenders, collateral agent and as lead arranger, and Wells Fargo Foothill, LLC (Wells Fargo), as a lender and borrowing base agent for the Lenders.

Pursuant to the Thirty-Fifth Amendment, and upon the terms and subject to the conditions thereof, the Waiver Reserve expiration due to occur on June 15, 2009 was extended until June 22, 2009. In addition, the Forbearance, granted in the Twenty-Second Amendment, which was due to expire on June 15, 2009, was extended until June 22, 2009.
