The Registrant expected to obtain representations from Arthur Andersen LLP ("Andersen") to support filing a letter (the "Exhibit 99 Letter") under paragraph (b) of Temporary Instruction A-T2 to Form 20-F with respect to the audit of CompUSA, Inc. ("CompUSA"). CompUSA is an equity method investee of the Registrant, and the report of Andersen on the financial statements of CompUSA is included in the Form 20-F under S-X Rule 2-05 because the report of Mancera, S.C., a member practice of Ernst & Young Global, on the Registrant's financial statements expresses reliance on the Andersen report. The Form 20-F could not be filed on July 1, 2002, because the Registrant was unable to obtain the representations from Andersen. The Registrant will file the Form 20-F on July 2, 2002, without the Exhibit 99 Letter.
