1. This Registration Statement covers 2,000,000 shares of voting common stock, \$0.01 par value per share, of Wright Medical Group, Inc. (the Common Stock ) issuable pursuant to the Wright Medical Group, Inc. Second Amended and Restated 1999 Equity Incentive Plan (the Plan ). The Plan authorizes the issuance of a maximum of 6,767,051 shares of Common Stock, including the 2,000,000 shares being registered hereby. In addition, this Registration Statement covers an indeterminable number of additional shares of Common Stock as may hereafter be offered or issued pursuant to the Plan, to prevent dilution resulting from stock splits or similar transactions effected without receipt of consideration and pursuant to Rule 416(c) under the Securities Act of 1933, as amended (the Securities Act ).
2. Estimated solely for calculating the amount of the registration fee. The registration fee has been calculated pursuant to paragraphs (c) and (h) of Rule 457 under the Securities Act based upon the average of the high and low sales prices of the Common Stock as reported by the Nasdaq National Market on September 4, 2003.

INFORMATION REQUIRED IN THE REGISTRATION STATEMENT

The stockholders of Wright Medical Group, Inc. (the Company) originally approved the Company's 1999 Equity Incentive Plan on December 7, 1999, and the plan subsequently was amended and restated on July 6, 2001. On May 13, 2003, the Company's stockholders approved an amendment increasing the number of shares of Common Stock available for awards thereunder by 2,000,000 shares, which are the subject of this registration statement.

The contents of the Company's earlier Registration Statement, file number 333-75176, are incorporated herein by reference.
