The Plan authorizes the issuance of a maximum of 9,767,051 shares of Common Stock, including the 1,500,000 shares being registered herein. In addition, this registration statement covers such indeterminable number of additional shares of Common Stock as may hereafter be offered or issued pursuant to the Plan to prevent dilution resulting from stock splits or similar transactions effected without receipt of consideration and pursuant to Rule 416(c) under the Securities Act of 1933, as amended (the "Securities Act").
  2. These figures are estimated solely for the purpose of calculating the amount of the registration fee. The registration fee has been calculated pursuant to paragraphs (c) and (h) of Rule 457 under the Securities Act based upon the average of the high and low sales prices of the Common Stock as reported by the Nasdaq National Market on May 20, 2005.

REGISTRATION OF ADDITIONAL SECURITIES**

The stockholders of Wright Medical Group, Inc. (the Company) originally approved the Company's 1999 Equity Incentive Plan on December 7, 1999, and it was subsequently amended and restated on July 6, 2001, May 13, 2003, and May 13, 2004 (the Equity Incentive Plan). On May 12, 2005, the Company's stockholders approved an amendment to the Equity Incentive Plan which (a) increased the number of shares of Common Stock available for awards thereunder by 1,500,000 shares, which are the subject of this registration statement, and (b) clarified that any and all shares of common stock that may be made subject to awards under the Equity Incentive Plan may be issued pursuant to incentive stock options. The contents of the Company's earlier registration statements related to the Equity Incentive Plan (File Numbers 333-75176, 333-108638, and 333-115541) are incorporated herein by reference.
